Fundraising Updates

A total of **\$9,287.50** has been raised (updated 10/16).

 - \$408.50 from extra bundle donations.
 - \$120 from extra marquee donations.

- **8th Grade Bundle:** \$4,360 (66 sold with 38 adding delivery).
